Will History (2014-15) Repeat Itself?

ot too long ago, the community rejoiced when an almost two year long stay order on allotment of housing to members of the community was lifted, thanks to the efforts of the new BPP Board Trustees -Desai, Dadrawala, Bhathena and Randeria. A little known fact is that even after the new Trustees approached the Charity Commissioner (CC) requesting him to lift the stay order, both - ex-BPP Chairman Dinshaw Mehta (in person) and Trustee-in-absence, Munchi Cama (through his advocate), vehemently opposed this request. However, the CC decided to accept the plea of the new Trustees and the stay order was lifted.

The community rejoiced. The first six months saw the new Board working dedicatedly in the interest of the community allotting 65 flats within the first six months of their working, compared to the last Board's sorry stats of allotting 75 flats in seven years.

But, as they say, all good things come to an end, and once again the community finds itself at the receiving end of the unending battles within the BPP, triggered allegedly by external hands. Even as all sides inexhaustibly harp on about their legal rights, petty reasons and myopic visions of right and wrong, the greater good of the community yet again is lost amidst a flurry of whatsapp messages and social

media misuse.

Parsi Times has gone beyond the words and the huffing and puffing of our Trustees, and is putting before the community details of the recent happenings chronologically, as per the documents available with us. We do not intend to join the 'tu-tu-main-main' blame game and disrespect the time or intelligence of our readers.

Fact File:

The 2013 cash payments controversy resurfaced month ago; allegedly fresh evidence was now available and put forward before the press by the complainant ex-Trustee Khojeste Mistree and some of the present Trustees. When asked why this old issue was being raked up, the facts that emerge add up thus: Musharaf (main tenant in the Dady Building Controversy) approached BPP and requested the new Board execute his pending tenancy agreement as he had already made the full payment. All six Trustees accepted this and passed a resolution to this effect. Musharaf was called the next day and asked to clear his outstanding dues, which he did. A rent receipt was issued to him and he was asked to withdraw the case that he had filed against the BPP. This too was done. All this was as per the resolution passed unanimously by all six Trustees. However the records show that when the agreement was to be signed, five of the Trustees, including Armaity Tirandaz,

signed it. Only Viraf Mehta did not. Subsequently, the records show that Tirandaz decided to withdraw her signature and the remaining four Trustees signed a fresh agreement.

So how does this solitary issue turn into a major stumbling block for the community?

The allegations, whatsapp messages and audio recordings that followed these events seem to indicate that Musharaf had become a key player in this saga of an alleged cash transaction by the ex-Chairman Dinshaw Mehta. Apparently the signing of the tenancy agreement is the carrot or the stick (depends on which side of the fence you are looking from) which can prove or disprove this allegation made by Khojeste Mistree against Dinshaw Mehta. The anonymous whatsapp messages attaching clips of an alleged meeting between Dinshaw, Viraf and Musharaf at Musharaf's house appears to be the straw that will break the proverbial back of the camel.

Whether there is any link between this alleged cash transaction and the subsequent

events, which are threatening the functioning of the BPP, once again, remains to be seen..

On the 25th of July 2016, Munchi Cama, through his lawyers, sent a notice to different offices of the Registrar of Documents requesting that no documents (tenancy, L&L, etc.) should be registered without his signature. This attempt, if successful, will not just stop the execution of the Musharaf tenancy agreement, but will effectively stall all housing allotment agreements - unless he had also signed them, as the 'seventh' Trustee.

On the very same day, Viraf Mehta and Armaity Tirandaz also wrote a letter to various offices of the Registrar calling upon them not to register the Musharaf tenancy agreement, claiming that "all the facts" were not informed to them. It is not specified in the letter as to who was supposed to "inform" them as Armaity Tirandaz is herself a continuing Trustee,



Perform Or Perish

Dear Editor.

Over 20 like-minded people of our community, along with some directly affected applicants, whose Leave & Licence were affected, took an impromptu initiative to visit the BPP office on Aug 30, 2016 to meet the Trustees with reference to Viraf and Armaity's legal notice cautioning of illegality being committed by some of the present Trustees - as a result of which Housing allotments to 20 applicants went on hold.

Such a move is against the interest of the community. Trustees Armaity Tirandaz and Viraf Mehta claim through the legal notice that allotments on Tenancy/L&L not signed by all seven Trustees will be deemed illegal. Let us refresh Armaity Tirandaz's memory to a couple of years back, about an allotment to Neville Mehta, nephew of Dinshaw Mehta. Out of 6 Trustees present, Dinshaw Mehta abstained from voting since it was his nephew. Of the remaining 5 Trustees, 3 Trustees voted in favor of allotment while 2 Trustees Yazdi Desai and Khojeste Mistry were against the allotment. Since the majority of the Trustees approved and signed the agreement, Yazdi Desai and Khojeste Mistry respected the majority decision and signed it. Can Armaity Tirandaz and Viraf Mehta not follow the same? This, in our opinion, is the highest form of double standard adopted by a sitting Trustee on both - the previous and the current board!

It is important to note that Armaity Tirandaz in her Facebook response misguided the community by mentioning that she, along with Viraf Mehta, decided to consult a senior counsel since the majority trustees felt it not necessary. Consider this - Manchi Cama's letter was dated July 25, 2016. Let us assume that it reached BPP on July 26, 2016. At such short notice, it cannot be kept on the agenda nor a hurried decision could take place on July 26, 2016. On July 27, 2016 the notice was issued by both to the Co-Trustees! Where was the time to even discuss the same in the Boardroom? In 2 days after Camas letter, Armaity and Viraf served notices to the BPP. Why the tearing hurry?

This was a personal decision to consult a senior counsel and not that of the Board, though Armaity Tirandaz claims that the co-trustees did not feel it necessary for such an opinion. If both, Armaity and Viraf would have only read Clause No. 32, they too would not have felt the need to approach the senior counsel. Clause No. 32 states, 'Whenever any difference of opinion shall arise amongst or any decision is required to be taken by the Trustees upon any question, matter or subject, the same shall be decided according to the opinion of the majority of the Trustees and in case of an equality of votes, by casting vote of Chairman of the meeting at which the vote is taken. Such decision shall bind the rest and shall be adopted and acted upon'. This step in my opinion is done with intent to stall allotments to the deserving. Notices such as the one issued by Viraf and Armaity are against our community.

I leave it to the community to decide if senior counsel advice was required? Armaity Tirandaz should be well aware as in the case of Parsi Lying In Hospital, she along with Dinshaw Mehta, were advised by the High Court to go with the majority and abide by Clause 32. Can this be denied? We should not fool the community with stories. Provide evidence to the community when clarifying a stand and give the community the complete, true picture. Time is not far when begging bowls will be drawn out again for votes. Because of one-up-manship attitude it is the community that suffers. Don't take their curses. Serve the community.

We, the group members also take this opportunity to thank all the Trustees for giving us their time and assuring us that the allotments will take place barring those against it. If the issue is not resolved within a week from the date of publication, we would be compelled to invite all Trustees to visit all colonies and take questions depending on response from the community. We would request support from all community members and all Associations from colonies to come forward and support this cause. An evening for our community is not asking for too much. We patiently heard these Trustees when they came for votes, now it's time for them to fulfil their promises. We refuse to wait for 7 years - we want results now. Either perform or perish.



Er. Bajan: The word 'Farvardin' is dedicated to Fravashis who are the protectors and guardian spirits of all souls.

The 22nd section of the Farvardin Yasht tells us that they take care of the development of physical organs of a child when it is in the mother's womb. The 13th Section (Karda) of the Farvardin Yasht, named the Arda Fravash Afringan, is in praise of all the Fravashis collectively."

PT: Can you explain the concept of Fravashis?

Fr. Bajan:
Fravashi is a
word in the Avesta language,
derived from 'Vaksh', meaning
growth or 'to increase' and
'Fra' means to move forward.
Hence, the meaning is growth
and progress. The word 'Asho'
means righteous and holy.
When we invoke the presence
and blessings of Fravashis

during the ten Farvardegan days (Muktad), we venerate them by offering them prayers, fruit, flowers and clothing (Siyaav).

PT: What does the prayer 'Ashaunam Vangheush Surao Spentao Fravashiyo Yazamaide' mean?

Er. Bajan: The prayers on Farvardigan begin with the words 'Ashaunam Vangheush Spentao Fravashiyo Surao Yazamaide', meaning that we invoke and venerate the righteous, brave, beneficent and holy Fravashis. It is vital to listen to the voice of the Fravashis guiding our lives, thereby always thinking good thoughts and performing them into virtuous words and actions, thereby safeguarding the purity of our soul.

Baj Ritual - An Indispensable Prayer - Part II

The sacrosanct Baj ritual is intrinsic to almost all the rituals performed by Priests, during and after performing ceremonies, tasks and even normal activities. In this regard, **Ervad Pervez Karanjia**, Panthaky of the Sodawaterwalla Agiary (Dhobi Talao) demystifies this in a discussion with **PT Writer Jamshed Arjani**, in a special two part series.

PT: What are the other Baj rituals performed by Priests?

Er. Karanjia: Only priests who have become Navar as well as Maratab can perform the Baj ritual. A Baj ritual consists of reciting prayers which are uttered mutely from commencement to conclusion without any verbal or physical disturbance or interruption. Priests performing the Baj rituals need implements and edible items - importantly the daran (small discs of wheat flour), unleavened pomegranate seeds, and water. The Baj ritual is performed within a perimeter of tiles with lines between them, known as 'Pavi'. Other essential implements include two 'karasya' (mugs made of German Silver); a 'kahana' (a large pot made of German Silver filled with water); a 'fulya' (small metal bowl); 5 small metal wire chains; 2 chains made of German Silver; a 'khumcha' (tray made of

German Silver); and a 'Aesam

Boi', a stone slab for Sukhad

and Loban (sandalwood and incense).

Prior to commencing the pertaining Baj ritual, the priest recites the Panj-Tae Baj, using the bundle of five wires, which empowers him with the tenacity

and endurance to perform four more Baj rituals without tiring and also the endurance to perform other higher rituals. After concluding the Baj ritual, the priest partakes of a bit of Daran from its edge, alongwith some ghee pomegranate and seeds. He then relinguishes the Baj ceremony.

Prior to
constructing a Dokhma,
Dokhme Nashini Baj is
performed, dedicated to Sarosh
Yazad and other Ameshaspands.
A Baj ceremony is also
performed after the Dokhma
is constructed, alongwith the
Yajashne, Vendidad, Jashan and

other rituals.

The Anushahe Ravaan Ni Baj ritual is performed on all the days when a devotee has the Afarghan and Farokshi rituals performed in memory of a deceased person.



Other Baj rituals performed for various reasons are the Panth Yazad Baj during higher rituals, the Neryoshang Dhaval Baj which was composed by Dastoorane-Dastoor Neryoshang Dhaval and the Agreras Baj. The most crucial four Baj rituals performed on the morning of the Chahrum day are dedicated to Rashne Yazad and Ashtad Yazad who pass judgement on the departed soul's deeds, Mino-Ram Yazad who delivers the verdict and

the group of Fravashis, the spirits of earlier departed souls, known as Arda Fravash. During the Baj ritual dedicated to Mino-Minoram, an Akhand Siyaav consisting of priestly vestments are offered on a tray. Unless these four Baj rituals are performed, it is impossible for the soul to proceed to its final destination and it lingers in anguish.

The Baj of Siroja Yazad is most vital as Siroja Yazad assimilates all the angels within itself, including Burjor Yazad, Dahm Yazad and Hom Yazad. The Siroja Baj is performed one day before the monthly memorial prayer for the deceased and raying this

Baj evokes all the 33 angels.

All the days of Shahenshahi calendar dedicated to Yazads Ameshaspands and a devotee can have the Baj and Afarghan rituals performed on any day in praise of the angel after whom the day is named. Four darans are cooked for the performance of all Baj rituals except for the rituals dedicated to Sarosh Yazad, for whom six darans are placed in the Baj rituals because the Gathas tell us that Sarosh Yazad is the foremost and greatest Yazad who revealed our religion to us. Therefore in the Sarosh Yasht Vadi, the 10th passage (Karda) describes him as 'Yo Daeno Diso Daenyao', the Yazad of all Yazads. Another reason given is that Sarosh Yazad accompanies the soul of a deceased person to the Chinwad Bridge through six different spheres or worlds. The 'Behram Yazad Nu Daran' is a ritual during which a joyful Baj ritual is also performed, hence the daran in this Baj are sweet.

NOSHIR H. DADRAWALA

e was a Saint who led a Simple life - A Priest but not Pedantic -An Alchemist but he never abused the knowledge or power he was blessed with -An Astrologer but not prone to Alibi - A Healer with a Heart of gold....

Dasturji Jamshed Sohrab Kukadaru was born in Surat on 26th May 1831 (Mah Ava, Roj Zamyad) and passed away on 5th September, 1900 (Mah Fravardin, Roj Behram) of the Shahanshahi Yazdezardi calendar. He was unique. His greatness lay in his simplicity and his piety and we remember him to this day.

Simple Lifestyle: He was Panthaky (managing Priest) of the Kapawala Agiary and commanded the respect of his peers and the Behdin (laity). He washed his own clothes and ate only one meal a day which consisted of rice and ghee (clarified butter) which he used to cook by keeping a vessel filled with rice in the rays of the

sun and reciting sacred Avestan verses. He was a vegetarian by choice and spent most of his time in offering prayers. Although the title of Dastur (High Priest) was conferred on him posthumously, the behdins regarded him as a Dastur even during his lifetime. Whenever he attended a wedding or navjote, the whole gathering would stand up as a mark of respect.

Dasturji had Astrology: qualities developed clairvoyance as a result of certain tarikat (spiritual discipline), amal (ritual power), manthravani (prayers) and leading a life of ashoi (righteousness). He is believed to have accurately predicted the day and time (to the hour) of Dastur Peshotan Sanjana's death as also the death of Queen Victoria and Sir Dinshaw Petit

Once, when a marriage procession was passing through Chira Bazaar in Mumbai, Dasturii sent word that the procession should halt for about an hour. No one paid any heed. Within a short time, there was an accident and the bridegroom died on the spot.

Scholarship: He had comprehensive knowledge of Avesta and Pahlavi. He served as a teacher at the Seth Jijibhai Dadabhai Zend Avesta Madressa at Fort, translated certain volumes of the Pahlavi Dinkard and contributed regularly to a iournal called 'Yazdan Parast'. He had also brought out various booklets, one of which was 'Khoasa-e-afringan' in which he advocated reciting the 'Tao ahmi nemane' karda.

Healer: Dasturji, with the power of his ashoi (holiness/ righteousness) and manthravani (prayers), healed a number of ailing and suffering persons. For instance, when Jehangir Karkaria, a teacher at Bharda School, was just three, he had a severe attack of jaundice, and the doctors had given up hope. His grandmother took the ailing boy to Dasturji at the Agiary. He made her sit at a certain spot with the ailing child in her lap. Dasturji sat at some distance and began praying after placing a brass bowl filled with clean well-water between

them. As Dasturji prayed, the water in the bowl began to turn yellow and the child began to recover. The child grew up to be a well-regarded teacher and mathematician and died at a ripe old age.

Spiritual prowess: One day, a Muslim Pir (Saint) appeared at the gate of the Kappawalla Agiary with a view to test Dasturji's spiritual powers. After some discussion, the Pir challenged Dasturji to bring the water level of the Agiary well to the surface. Dasturji agreed, but warned that if the water overflowed, the sin of wasting water would be on the Pir's head. After performing the Padyab Kushti, Dasturji began to pray. Towards the end of the prayers, the water level began to rise. When the water surfaced right up to the top, the Pir implored Dasturji to stop. The water receded and the Pir left chanting Dasturji's

Alchemist: The miracle for which Dasturji is most renowned is the one connected with the establishment of the Anjuman Atash Behram. Reportedly, Dasturji Saheb transformed an ordinary mud brick into a large bar of gold by chanting Avestan prayers throughout the night. This was on request of

Zoroastrian devotees to cover a shortfall in the funds required for constructing the Anjuman Atash Behram building at Dhobi Talao, in Mumbai. Kukadaru Saheb requested Dasturji Kaikhushru Jamaspji the High Priest to go to the next room and sell the item which he would find there. The item happened to be a gold brick which, in those days, fetched a handsome sum of Rs. 10,000/-

It is likely that Kukadaru Saheb was well-versed in the science of Alchemy. We know today, in the light of modern science, that when the number of protons in the nucleus of an atom of any element is changed (i.e., increased or decreased) the element itself can change from one to another. Perhaps Dasturji with his ashoi and manthravani had the power to alchemise metals.

Amazing and extraordinary as this 'miracles' may appear, the famous English Scientist, Alfred Russell, believed, "a miracle is nothing but certain laws of Nature which we neither know nor understand." Mystics like Dastur Azar Kaiwan. Dastur Meherji Rana and Dastur Kukadaru understood and knew these Laws of Nature and used them for righteous purposes.

POLITICAL FACE-OFF

In keeping with our policy of ensuring both sides of the story is heard, PT presents Trustee Viraf Mehta's take on the ongoing scenario

et me start by apologizing for this sordid state of affairs at the BPP. Never, when I stood for elections, did I expect some of my fellow Trustees to behave this way. A lot is to be said and explained, but for now, let me address only the allegations made by Trustee Yazdi Desai (YD) against Trustee Armaity R. Tirandaz (ART) and myself.

Let us set the record straight. In 2013. YD moved the Charity Commissioner and put a stay on Housing, so that my father, Dinshaw Mehta, couldn't take part in housing decisions or chair the imminent World Zoroastrian Congress. YD had the Board's majority at the time. There was no need to bring in a stay order. Yet, in his wisdom he didn't relent and there were around 100-130 flats kept locked for almost three years. This is where the poor and needy actually suffered. All that the current Board is doing is allocating flats vacant since 2013 that should have been allocated three years ago. We are just covering up the error that YD committed.

Trustee Kersi Randeria and YD are obsessed with my father. They fail to see that I am my own individual and independently think as a Trustee. Despite all the slanderous messages floating around and the constant mocking of my family by Kersi Randeria in the Board room, I can still stand with my head held high, saying this decision made as a Trustee is prudent and in the interest of the Trust.

At the end of June 2016, 4 Trustees tried to execute and register a tenancy agreement to an individual, against whom YD and Khojeste Mistree had filed cases in the EOW and MRA Marg Police station, for misappropriation of charity funds. But now, with YD's own admission he has stated that the charges levied were false. I informed that Board that I have been legally advised that a Trustee of the BPP cannot enter into any agreement, leave alone a Tenancy Agreement, with an individual against whom the BPP or a Trustee has filed a case of collusion in misappropriation. While Mr. Mistree no longer remains a Trustee of the BPP, the case was filed while he was. So all I requested the Board, especially YD, was to let the complaint against the accused be withdrawn, since YD himself agreed he was innocent, and then without any hesitation, ART and I could sign the tenancy.

Unfortunately, this request fell on deaf ears and the 4 Trustees, namely Kersi, Yazdi, Zarir and Noshir had a new Tenancy agreement drawn up with only their 4 names on it. I was shocked at the brazen attitude by my colleague Trustees and since ART and myself were left with no other option, we informed

the Sub-Registrar not to register any Agreement which was ab-initio invalid and against law.

In the meantime we received a legal notice from Mr. Munchi Cama's lawyer (Homa Petit's legal firm of Vigil Juris) that all execution and Registration of any Tenancy or Leave License Agreement would be illegal unless signed by all seven Trustees. ART and I insisted on getting a legal opinion about the implications of Mr. Cama's notice but the majority Trustees again decided to go ahead with only 6 Trustees. We naturally refused to be a part of such breach till we obtained proper legal advice on this issue. As simple a request as this has unfortunately been blown out of proportion. It has only been 3 weeks that we held back our signature until we get legal opinion, which is refused by majority 4. I was shocked to see YD's write up in the Kersi Randeria owned PT.

To put things in perspective, while some Trustees would like to state that Munchi has resigned, it is a fact that MNC's signature is still on all the BPP related bank accounts. Not just that, when we file cases on beneficiaries or when we want to settle cases by filing consent terms, we send the legal documents to MNC's house for his signature which he does. This practice has been going on since we took office in October 2015 right till August 2016.

Neither ART or myself are from a legal background and we do not want to be on the wrong side of the law. We have executed over 50 Leave License Agreements but when the four Trustees threaten to execute Agreements with persons who are co-accused and when Mr. Cama sends legal notice of our default and we seek legal guidance, we are ignored leaving us no alternative but to complain to Sub-Registrar not to register any Agreement unless signed by all seven Trustees.

To think that ART or myself would deprive the poor and needy is an absolutely absurd assumption on the part of YD. Until the middle of July, we have ALL Collectively signed around 50 LL agreements. It was only after we received a notice from Mr. Cama's (MNC) lawyer ART and myself decided to hold off signing until the Board gets a legal opinion to continue as we have with only 6 signatures.

As per unofficial legal advice obtained by us, since all properties of BPP vests in all seven Trustees, all Agreements have to be executed by all seven Trustees and only four Trustees cannot arrogate to themselves the power to execute and register such Agreements. Since the matter is now sub-judice let the law take its course." A Revert By BPP Ch. Yazdi Desai and Trustees - Dadrawala, Randeria and Bhathena

rustee Viraf Dinshaw Mehta begins with an apology. He certainly has a lot to feel sorry for, starting with his seldom using his mind on any issue, without first consulting his father Mr. Dinshaw Rusi Mehta. He always has after-thoughts and change in his thinking after almost every meeting. No prizes for guessing why. Dinshaw Mehta has refused to retire gracefully and his son, Viraf Mehta has decided to be 'His Father's Voice' at the BPP.

Viraf accuses Yazdi Desai for moving the Charity Commissioner (CC) in 2013 and bringing in a stay order. But, he conveniently does not disclose why Yazdi had to take this step and what Desai had originally gone to the CC for. Yazdi had moved the CC to restrain only Dinshaw Mehta, because there was a charge of suspicious cash dealing. But, Dinshaw Mehta insisted that all the Trustees should be restrained, and that's the way the CC ruled. Therefore, to use Viraf's own words, "This is where the poor and needy actually suffered."

Viraf glibly talks about "slanderous messages floating around." We would like to ask him as to who ignited the messages regarding the allotment of flat to Dr. Farokh Master and that too several months after the matter was approved unanimously. It was Viraf Mehta and his father and the reason being, that at the same time the Board was reinvestigating allotment of a flat to another homoeopath at Godrej Baug from a building now belonging to Mr. Mehta. Viraf also needs to answer who ignited the messages about a so-called 'ban on Jame' the very next morning, after the Trustees decided to merely stop advertising in that weekly.

Viraf again lies when he says, "At the end of June 2016, 4 Trustees tried to execute and register a tenancy agreement to an individual against whom YD and Khojeste Mistree had filed cases in the EOW and MRA Marg Police station of misappropriation of charity funds." The fact is, the resolution has been passed and signed by all the Trustees unanimously, including Viraf. Viraf had after thoughts after consulting his dear daddy!

He says he has been legally advised "that a Trustee of the BPP cannot enter into any agreement, leave alone a Tenancy Agreement, with an individual against whom the BPP or a Trustee has filed a case of collusion in misappropriation." He is misleading the community by alluding that it is the BPP which has filed the case. Once again, we must note that it is the individual, an ex-Trustee who has filed the complaint, and NOT the BPP. Further, please note that it is merely a complaint - there is

no ongoing case.

We hope Virafs lawyers are aware that every citizen of India, including the one who is accused, is presumed to be innocent until proven guilty, as part of his Fundamental Rights. He has also not disclosed the legal source either to the Board or to the public. Here is a man who has paid all the money to the Trust and is in possession of the flat. All that the Trustees were required to do was execute the Tenancy Agreement! What is illegal about this? It is also interesting to note that Viraf's father Dinshaw, Munchi Cama and Armaity Tirandaz have written a letter in February, 2014, stating clearly that this Tenancy Agreement must and should be executed!!

Viraf talks about a legal notice from Cama's lawyer but, he does not mention that an almost similar notice was also served to the majority Trustees by Tirandaz's lawyer. In the Board room, Tirandaz could not even remember the name of her own lawyer, much less realize that the notice was literally a 'cut and paste' job from the notice served by Cama's lawyers! As a Board, we do feel sorry for her.

Viraf mindlessly talks about getting a legal opinion regarding Cama's resignation. He should know that Cama's resignation is a matter before the Charity Commissioner and it is for the CC to decide whether he stays on as Trustee or not. Therefore, while this matter is still before a quasi-judicial authority, would any legal luminary worth his salt give an opinion to direct the Trustees on what they should do or not do?

We forgive Viraf for his ignorance of the law and generally all his ignorance on matters concerning the governance of the Trust. Yes, Mr. Cama's signatures are still on the records of all banks because unless the CC decides in the matter, the Trustees cannot instruct the banks to remove his signature. But, is Mr. Cama signing cheques? The answer is NO! Similarly, Mr. Cama's signatures are taken on record where certain legal cases and settlements are involved.

Viraf's conclusion wherein he talks "unofficial legal advice" is laughable. He fails to point out Clause No.: 32 of the 'Scheme of Election', framed by the Bombay High Court, which was upheld by the same court in the case of the Parsi Lying-In Hospital - that the decision of the majority is binding on the minority. In fact, till it was convenient, it was a clause that Dinshaw Mehta used to quote all the time! But, now that his son is suddenly in the disruptive minority, he is singing a different song. This is a common trait with the Mehtas - they blow where the wind blows - there is never consistency in their thinking, beliefs or loyalty.

Housing:

With a heavy heart I inform the community that allotment of houses to the poor and deserving has received a set back because 2 Trustees, Viraf Mehta and Armaity Tirandaz have chosen not to sign any more Leave & License Agreements and have written to the Registrar of Assurances at the various registration offices in Mumbai "to refrain and restrain from taking any steps towards execution and registration of any agreement of Tenancy, Leave License or Conveyance of any property of the Trust". They want Munchi Cama's name to be included in the L&L Agreements. Cama's Resignation Case is before the Charity Commissioner, who alone will decide Munchi Cama's fate as a Trustee. How or why Viraf and Armaity have chosen to overrule this authority and concluded that Munchi Cama continues to be a Trustee,

attended a single hearing in his own case nor attended any BPP Board meeting since 12th May

opinion, this ln my conduct is a cruel joke on our community. I humbly request and urge my team members, Viraf and Armaity, not to hold the community to ransom by pandering to the wishes of persons outside the BPP who have vested interests and want to hurt the BPP, so as to show the new Trustees in a poor light. On my part, I will do my best to ensure that the BPP continues to fulfill our beneficiaries' need for housing without further interruption.

Union Settlement:

Finally the Wage agreement between the BPP and Class IV employees has been signed and sealed. The highlights of this agreement include extra considerations given to Khandhias and Nassesalars and emphasis will be placed on retirement benefits like gratuity.

Clearing Cobwebs:

We have taken special initiative to undo the mistakes of the past. Over a decade ago, Everest Builders claimed that the middle of Panthaki Baug, Andheri, In 2012, the BPP Board was persuaded by one Trustee to make an application to the Charity Commissioner for permission to exchange this landlocked plot with a similar sized plot in one corner of Panthaki Baug, abutting an access road. The rationale for this exchange was that having a plot belonging to someone else in the middle of Panthaki Baug would fragment the Baug, and there could be a Non-Parsi development in the middle of a Parsi Colony in future. To avoid this, the Trustees were advised to exchange a similar size plot of Panthaki Baug, which was abutting the main road with this landlocked plot in the middle of Panthaki Baug. Fortunately, this application was stalled mainly due to objections by certain public spirited community members like Homee Dalal. As part of my Board's commitment to reduce litigation, this application was thoroughly reviewed bringing to light serious irregularities and other similar information crept in - the PR card in respect of Everest Property does not reflect the name of the owner; the exact boundary of the

landlocked plot was disputed; a nullah, which ran through the plot, was owned by the State and no development is allowed

over it as per the Municipal rules; also, a landlocked plot could not be developed if the access is less than 1.5 mtrs wide

A few facts which Armaity Tirandaz's Clarification failed to bring up.

In PT's last issue, I had shared with the community that that my Trustees, Armaity and Viraf, have effectively stopped allotment of houses by not signing on Agreements and by writing to the Registrar not to register documents. To this, Armaity issued a 'clarification' on social media - Facebook and WhatsApp - accusing me of lying to the community. In her clarification, Armaity says that when she and Viraf received a copy of Munchi Cama's letter to the Registrar to stop registrations, she and Viraf pleaded with the Board to get a legal opinion and since we (Trustees Kersi, Noshir and Zarir and myself) did not agree, they had no option but to stop signing agreements and wrote to the Registrar to stop registrations, till an opinion was obtained by them.

This is a complete lie because Armaity and Viraf sent a letter to the REGISTRAR, SIMILAR TO THE ONE SENT BY MUNCHI TO THE Registrar, on the SAME DAY AS MUNCHI CAMA DID, which was Monday 25th July 2016. But, our BPP Board meetings are held on Tuesdays and therefore there was no question of any discussion taking place. They had already written to the Registrar before any Board Meeting! Armaity and Viraf did not inform the Board of their writing to the Registrar. They did not even send a copy to the Board. They did it secretly. It was only when our Vada Dasturji Khurshed Kotwal

was taken for his registration on 12th August 2016, that the other Trustees came to know that Viraf and Armaity had written to the Registrar!

Armaity has also mentioned in her 'clarification' that I had taken more than 2 dozen adjournment dates in Munchi Cama's Resignation Case, thereby delaying the proceedings. The fact is that Armaity has not attended a single hearing of Munchi Cama's Change Report at the Charity Commissioner's, which has been going on since June 2015! Yet, she authoritatively says in her 'clarification' that I have taken adjournment dates on more than 2 dozen occasions! I've taken ONLY ONE ADJOURNMENT DATE as I was attending another Court Case at Vadgaon on June 8th, 2015. It's utterly disappointing and sad to see Armaity resort to such blatant lies.

Armaity further stated that I have not provided any precedence or legal validation regarding our contention that the Board can function with only 6 trustees. Here is the precedence - it happened when Silloo Kavarana expired on 17th October, 2005 and the BPP functioned for 3 long years with only 6 trustees till 23rd October, 2008.

Therefore this application

exchange this 'useless' landlocked plot with a prime plot abutting the main road was definitely not beneficial for the community. Therefore the new Board decided to withdraw the Exchange Application filed with the CC. Everest Builders threatened to physically build a wall around their alleged plot. So, on 15th August 2016, my colleague Trustee Kersi Randeria and I went to Panthaki Baug, interacted with residents, informing them of the exchange of plots issue. We immediately arranged extra security for guarding the property and also roped in residents as volunteers to report any activity in the area. Thanks to Homee Dalal for saving our community's property.

Gamadia Colony, Tardeo:

The far end of Gamadia Colony is bound by a hill atop which overlooking the Colony are hutments without sewage or garbage collection facility by the BMC for the residents. The garbage and sewage water flowed down the hill into Gamadia Colony's Buildings 15 and 16. Complaints to the BMC would result in cleanups of the area but within a few days, it would be back to square one. A permanent solution was needed. With BPP supporting the the efforts of Gamadia Colony resident Khorshed Meherjee, MLA Mangal Prabhat Lodha was approached and a permanent solution has been worked on with a thorough clean-up of the hill, new sewage lines, new tiles and concretization of the ground behind the Buildings. In a few days, the project will be complete. Thanks to Khorshed Meherjee, Minoo Khan, BJP activist and Neville Broacha, President BJP South Mumbai Parsi Cell for contributing towards Gamadia Colony's clean and healthy environment. **Poverty Amelioration:**

The **BPP** provides monthly financial support to disadvantaged Parsis, mainly senior citizens with no source

of income. The monthly doles range from Rs.1200 to Rs.3000, based on individual cases. BPP supports 600 community members in Mumbai and India resulting in a yearly outflow of Rs. 1,18,82,800. On Navroze and at Jamshedi Navroze, the BPP gives an extra Rs.500 as a small token of Navroze

Recovering Locked / Unused / Under-used Flats:

The Custodians of Colonies and Baugs regularly submit to the BPP Office a list of flats lying locked, unused or used sparingly. My Board has taken into account these flats and their occupants are being contacted and persuaded to surrender the flats back to the Punchayet. It is the Board's request to all families who have more than one home, to please surrender the additional flat(s), so that we can allot these to those in desperate need of housing.

Protecting Old, Lonely Tenants:

A number of our senior tenants in our community, who have no regular source of income or caretakers, become vulnerable targets to those with vested interests who, under the guise of caretakers, induct themselves in their flats and usurp their tenancy. To resolve this, the BPP provides monthly financial support of Rs.15,000; unlimited medical expenses; and waiving of building repairs contribution, rent and service charges. In return, they agree, post demise, upon reverting the flats back to the BPP to give away to others in need of housing.

Strengthening The Organisation:

In keeping with our commitment to generate a professional culture and management in the running of the BPP, the Board will bring in India's leading audit firm, Deloitte, as Internal Auditors to identify and control shortcomings; suggest measures to mitigate risks: and make accounts more of a management tool than just a tax / regulatory compliance.

Digital BPP:

The major difference between my Board and the previous Board is that my colleagues do not measure their achievements on the basis of 100% attendance (and 0% performance), but strive to bring about a level change in the working of the BPP. Noshir Dadrawalla has taken the initiative to digitize BPP with the help of Yezdi Tantra (On-Lyne Computer Systems), to take BPP to the next level competence. This will of entail re-vamping the website and majorly boosting clarity through technology by including features like Livestreaming events; availability of Financials and BPP Reviews; information regarding Blood Bank, Matrimony, Other Trusts handled by BPP; Careers/Jobs; Donations; HPY; Resources: Rules. Forms: Complete Housing transparency Scholarships, Allotments, Redresals/Grievances: Voters Voluntary Service Digital Programs: Registry for Births and Deaths; Alerts; Competitions,

Zoroastrian Athletic Camp:

Just as I was concluding this piece for the Parsi Times, I received a phone call from Dara Doomasia (Rustom Baug) that in the Bombay City District Amateur Athletic Meet, 3 of our BPP athletes have won 4 Gold Medals! Heartiest Congratulations to them! BPP runs an Athletic Camp where Dara Doomasia and a few others coach and train our Parsi 'bachhas' - who have excelled in various fields of athletics.

In ending I sincerely hope that each of my Co-Trustees will act solely in the best interest of the BPP and our beloved Community, without



Garlic chopped; 2 tsp oil; 3 to 4 + for garnishing Basil leaves; 2 to 3 Iceberg Lettuce Leaves; 2 to 3

Lollorosso lettuce leaves; 2 to 3 Arugula Leaves.

Dressing:

1 tsp. Balsamic Vinegar; 3 tsp. Olive Oil; Salt to taste; 1/4 tsp. Crushed Black Peppercorns Method:

Marinate chicken breasts with salt, crushed garlic, 1 tsp olive oil, 1 tsp Balsamic vinegar, ½ tsp crushed peppercorns, rosemary and thyme. Mix and set aside for 10 to 15 minutes. Combine



mushrooms, red pepper, capsicum, yellow pepper, 1/2 tsp crushed peppercorns, salt, chopped garlic, remaining Balsamic vinegar, remaining olive oil and remaining crushed peppercorns in a bowl. Mix well

DON'T BREATHE

There's nothing a man cannot do, once he accepts the fact that there is no God' — so goes the tagline of the film.

Stephen Lang plays a blind Iraqi-war veteran living alone with his ferocious dog in an abandoned neighbourhood in Detroit. Three youths Rocky (Jane Levy), her boyfriend Money (Daniel Zovatto) and their friend Alex (Dylan Minette) - who secretly harbours intentions for Rocky - have made it a parttime and lucrative business breaking into homes. They learn that the war veteran has recently been awarded a huge sum of money as settlement for his daughter's death in a car accident. But what they've bargained for is not what they get.

Uruguay-born director Alvarez has helmed a wonderfully written screenplay, aided by some credible performances, especially Stephen Lang, one-time director of the Actors' Studio.

There are some astonishing sequences, notable one being when the Blind Man turns off the light switches, nullifying whatever advantage the wouldbe robbers may have had. When the film begins, the viewer's sympathy is all for the visually handicapped war veteran. But as events unfold, the balance of

sympathy shifts. Alvarez succeeds in keeping the viewer eng the characters. The film is more of a thriller than horror.

Don't Breathe is an uncompromising, noteworthy film o with some remarkable performances. It's only on close so technical deficiencies. But with a taut script, slick editing, decent cinematography and a few genuine jumpscares, there indeed won't be time to breathe!

The ageless Jackie Chan pairs up with Johnny The ageless Jackie Chair pair - - - - Knoxville in this cop-and-crook buddy actionadventure flick that, in terms of substance promises much, but due to its clichéd plot delivers little. Benny Chan (Chan) is a dedicated Hongkong detective bent on uncovering the identity of crimeboss Matador. Chan's detective partner Yung (Eric Tsang) is despatched to a watery grave apparently by Matador — but not before Yung tells Chan to look after his young daughter Samantha (Bingbing Fan).

Nine years later, Chan teams up with Connor Watts (Knoxville), an American conman-cumgambler who's duped a Russian casino owner of a million dollars. On the run, he witnesses Samatha's kidnapping. The handcuffed Connor, a potential ally who can nail the Matador, gives Chan the slip time and again. This is the ruse for director Harlin to take the viewers down several exotic locales such as Macau, Siberia, Mongolia and the Gobi Desert, Hungary, not to mention the Chinese mud-slinging

festival and a Russian folk dance. The action and stunts are definitely watchable, but at a shade under two hours, the film is a bit too long. It's the kind of film where the action director and cinematographer have laboured more than the director. After the three 'Rush Hour' films, 'Shangai Noon' and 'Shangai Knights', the 62-year-old Chan bravely tries to carry on the odd-couple formula in 'Skiptrace', which is already breaking box-office records in China.

Not a bad choice for the Chan fan.







સંત પુરૂષ જમશેદજી સોરાબજી કુકાદારૂનો જન્મ સુરત ખાતે રોજ જમીઆદ, માહ આવા ય.ઝ. ૧૨૦૦ના રોજ થયો હતો. એમનું મરણ મુંબઈ ખાતે રોજ બહેરામ, માહ ફરવર્દીન, ય.ઝ. ૧૨૭૦ના રોજ થયું હતું. જીવનના ૪૨ વર્ષ મુંબઈની કપાવાલા અગિયારીના પંથકી તરીકે ગાળ્યા હતાં. સાદં, સંયમી અને શિસ્ત ભર્યુ જીવન જીવી જનાર દસ્ત્રજી શાકાહારી હતા. દિવસમાં એક વાર ખીચડી-ઘીનું ભોજન લેતા. ચોખાના વાસણને સૂર્યના તડકામાં મૂકી માંથ્રવાણીના બળથી તે ચોખાને પકવી શકતા. બહારનો ખોરાક કદી લેતા નહીં. પોતાના કપડાં પોતે જ ધોતાં.

દસ્તુરજી પાવમહેલની પવિત્ર ક્રિયાના જાણકાર હતા. બરસનુમની પાકી જાળવણી કરતા. માંથ્ર અને યરનના પ્રખર જ્ઞાની હોવાથી પોતાના વિચારોને આકૃતિ મરજી મુજબ દૂર મોકલી, પોતાનું દર્શન અન્ય હમદીનોને કરાવી શકતા. આવા દસ્તુરજી કુકાદારૂ પારસી કોમમાં એક સંત પુરૂષ તરીકે પૂજાય તે યોગ્ય જ છે.



and closely involved in this transaction. This letter also called upon the office of the sub-registrar not to execute even L&L agreements unless signed by all seven Trustees. (It is relevant to note that both the letters/notices are written on the very same day and thus neither can be said to be a 'response' to the other.)

Clarifications issued by both Viraf and Armaity alleged that they tried 'very hard' to convince the other four Trustees to 'consider' Munchi's letter/notice, which the four Trustees refused. How such a claim can be justified, in keeping with the fact that both sets of letters were written on the very same day, is beyond logic and understanding.

Two days later, on the 27th of July 2016, Viraf and Armaity sent a legal notice to the various offices of the Registrar, threatening to take legal action if they registered any document without the signature of seven Trustees (including L&L Agreements). Two interesting facts that emerge from the perusal of

these three documents: 1) Viraf and Armaity did not mark or send copies of their letter of 25-7-16 or their legal notice of 27-7-16 to the other four Trustees; and 2) Even though the copy of the notice sent by Cama's lawyers on the 25th of July to the Punchayet was not received by any of the Trustees, the legal notice sent by Viraf and Armaity just two days later, records the fact that Cama's lawyers have sent the office of the Registrar a legal notice!

This was not to be the end of the sordid saga. As reported by PT in its breaking news column last week, Cama has now filed a case before the Charity Commissioner wherein he has prayed that the present Trustees be stopped by an order of injunction from doing any work as Trustees. He has also filed an Originating Summons (OS) in the High Court where the prayers are more or less along the same grounds as in the application before the CC.

Cama, who resigned on the 12th of June 2105, appears to have decided to assert his views after a period of 13 months. There is probably no connection to the Musharaf case (although Cama's notice and cases, if successful, will also help stall Musharaf's documentation) but the timing could not have been more opportune for those who would want to stall Musharaf, just so that he can be bullied/cajoled into changing his statement. Cama's resigned making serious allegations and calling upon the CC to appoint an administrator, an eventuality that has always worried the community given our vast properties, particularly the Doongerwadi lands.

One is forced to wonder about and question the timing of Cama's "realization" that the BPP cannot and should not function without all seven Trustees. Even after the October elections, for almost nine months, Cama did not raise this issue. Immaterial of the adverse timing, today it is a serious threat to the present functioning of the BPP Trustees. And even though many may question the bonafides of the cases and the timing, no one can deny that Cama is an intelligent and honest man. He has often been looked upon as a person who enjoys a legal fight and one can safely say that this is going to be a

long and a hard battle for the new Trustees, particularly the four who appear to be in the sights of the litigation, as the other two trustees Viraf and Armaity have already spoken on behalf of Cama. The three new Trustees, Dadrawala, Bhathena and Randeria are NOT a party to the change report case of Cama, which is before the Charity Commissioner. Only the Chairman Yazdi Desai is, as he was the reporting Trustee.

Whether Cama will succeed or not will determine whether the new Board will be able to continue the good work that they had started out to do. Whether intended or not, these challenges of Cama will play into the hands of the Mehtas, who allegedly have told Musharaf that they will ensure that his property will not be registered.

On 20th February, 2014, Cama along with Mehta and Tirandaz had written a letter to Musharaf's lawyer stating that "they were willing to admit execution" and "register the same". In fact the three of them in that letter have stated - "....that these three Trustees (Cama, Mehta, Tirandaz) have performed their duties

as the landlords..." So what has changed? Is it that the new Trustees (who obviously could not know as much as the old Trustees of the last Board) did not disclose to Armaity Tirandaz (who was a Trustee at that time and thus obviously was in the know of ALL THE FACTS) and to Viraf Mehta (whose father is the main accused and who would probably be the one man who would know the facts better than any other person) all the facts as both these Trustees allege repeatedly? Or is it that the affidavits, the alleged video and audio recordings that are now doing the rounds, as alleged proof of cash transaction in the Dadi House matter, which is the issue - from which attention is sought to be diverted?

They say that truth always emerges from the ashes of lies even if it may take its own sweet time. Till then, the community will suffer. One can only hope that better sense prevails and the poor and needy of our community are not put through the same disappointment and hardship as they were recently subjected to.

Surely they deserve better?
