



PARSI TIMES Community News SATURDAY, May 21, 2022 05 "L&L-To-Tenancy For ALL – Not Just The Rich," Says Trustee Kersi Randeria

The last few days have seen a spurt of advertisements claiming that while the three trustees wish to convert all Leave and Licences (L&L) to Tenancy, it is one Trustee Kersi Randeria, who is not just objecting but has also stayed the process of converting L&L to Tenancy.

Nothing can be further from the truth.

The L&L-Tenancy controversy started with Trustee Viraf Mehta tabling a very superfluous so-called 'legal opinion', on 21st February, 2022, which apparently was hastily prepared and put up before the Board. This legal opinion was, in reply, purportedly to a one-line query raised by Trustee Viraf Mehta which said, what are the impediments to convert L&L to tenancy.

The legal opinion primarily said cancel the L&L and make a fresh Tenancy Agreement, and pay the stamp duty. Period.

Such a superfluous legal opinion, without going into the details of the fiduciary duty of trustees, or the legal impact of such a transaction should it be challenged before the Charity Commissioner or the courts... nothing was dealt with, in this order.

More importantly, it should be noted that on 22nd February, the Divisional Bench of Bombay High Court was to finalize the Scheme of Elections and fix the schedule for the elections, either on that day or within a few days,

Since no time was given to the trustees to even read and understand this so called legal opinion, leave aside consulting senior legal, tax and audit experts, Trustees Noshir Dadrawal and Kersi Randeria requested that such a major policy issue as this should not be decided by a Board whose term was scheduled to end shortly.

However, the 3 trustees tried their best to ram it through.

The resolution in itself, when read, clarifies and confirms that none other than Trustee Xerxes Dastoor said, that we had made a commitment to the court not to take any major policy decisions and he also said that we could have a preliminary discussion, but not take any action on this.

Thus, it wasn't Trustees Dadrawala and Randeria who objected, it was Xerxes Dastoor who recorded his objections! This is in the recorded minutes of the meeting.

However, thereafter, the three majority trustees passed a resolution, noting a few very important points:

- 1. That Deposits taken from beneficiaries would be converted to donations. This very statement indicates that this so-called conversion benefit was more for the rich, who had paid deposits, rather than the ordinary Parsi beneficiary.
- 2. The resolution also was not a conclusive resolution, as it stated, very clearly, as this resolution was being approved, subject to it being approved by the auditors, legal expert and tax experts. How then, can a resolution be said to have been passed and approved, is anyone's guess

Despite these objections, the three Trustees approved converting 3 L&L agreements to tenancies, once again, subject to certain conditions. Each of these 3 so-called beneficiaries, are known close friends and strong supporters of the Mehta-Tirandaz-Dastoor camp. That this was going to be used as a political tool and an election gimmick was doubly emphasized by the 3 names that were chosen.

Trustee Randeria then approached the Election Commissioner, not from the point of view of objecting to the conversion of the L&L to tenancy scheme, but objecting to the timing of this drama, stating that this was nothing but a political sop, a gimmick to garner votes, with false promises.

The Election Commission upheld his view, and stated that this was indeed a major policy decision and should not have been taken. It also upheld the view that it was a sop being given for electoral benefits, and instructed the three trustees not to take any further action, either generally in terms of the resolution, or specifically in terms of the three names they had approved.

As per Clause 15 of the Code of Conduct: 'No inducement, financial or otherwise, shall be offered to the voter.'

Relevant excerpts from Chief Election Commissioner, Commodore Aspi Marker's Order dated 08 Apr 2022:

- 7. The CEC, in consultation with the five other ECs, has evaluated the submissions made by the Complainant and the Respondents and examined the documents on record. The discussions and the decisions of the CEC are as follows:
 - (viii) Considering that this proposal to convert L&L into Tenancy was a matter of discussion for so many years in the past, passing the resolution on 21st February 2022 just the evening before the final hearing of the election petition was to commence the next morning, does indicate that the resolution was passed keeping in mind the imminent elections and the curbs which were proposed to be imposed post the Scheme and CoC coming into force.
 - (ix)The actual act of conversion of three out of the 1900 BPP licensees, on 22nd March 2022 when the CoC was in force, has to be seen in this light. When this is done, there is no doubt that the actual act of conversion does, broadly amount to a premeditated inducement to the voters within the meaning of Clause 15 of the CoC.
 - (x) The Resolution dated 22nd March 2022 must also be seen independently of the Resolution dated 21st February 2022. Seen even in this light, the same would constitute an inducement to the voters within the meaning of Clause 15 of the CoC.

In gross violation of the direction of the Election Commissioner, the three, in blatant disregard of the Order, have now started advertising it, speaking of it in the minutes and have even used it in a promotional

video for their campaign.

The rather pathetic argument of the 3 trustees was that they were doing this on the grounds that they wished to bring parity between the Licensees and the tenants. They have not dealt with how they intend to protect the Parsi covenant, they have not dealt as to how the poor and middle class should also benefit and they've not dealt with the consequences from the point of view of Income Tax and other tax issues, if such a policy were to go through.

However, Kersi Randeria was aghast at this obvious favouritism towards the rich friends of these trustees. In an email dated 21st March, 2022, he has written:

- "1. After completing the conditions recorded in the resolution passed by the three Trustees (conditions underlined for identification) in the Board meeting of 21-2-2022, the Trustees resolve to first consider the poor and middle class Parsi and Irani beneficiaries (and NOT THE RICH AND THE ULTRA RICH) for availing the benefits of any such policy by BPP PAYING THE STAMP DUTY AND REGISTRATION CHARGES FOR AND ON BEHALF OF OUR LESS FORTUNATE BENEFICIARIES AND ONLY AFTER THAT CONSIDER THE MORE AFFLUENT MEMBERS OF THE COMMUNITY (INCLUDING THEIR FRIENDS AND FAMILY MEMBERS) for tenancy."
- 2. No rich beneficiaries be given tenancy till each and every poor and middle class beneficiary is given the tenancy rights
- 3. Trustees to declare on oath their relationship (familial relationship, personal friendship or persons from whom or from whose family members the Trustees or their family members have received any help or advantage) with the beneficiary who is requesting out of turn for tenancy rights."

This item was put immediately on the agenda as per the Trustee Randeria's request.

Randeria was clear, if such a benefit was legally possible from the tax angle and the audit angle, then it should not be given to the rich. But rather, this protection should be first and foremost given to the poor and middle-class beneficiaries - the ordinary Parsis in the baugs, rather than to those rich Parsis who have given donations and deposits.

This is what Randeria has said and this is what he wants. Therefore to say that one Trustee is opposing the conversion of L&L to tenancy is not true.

The division in the Boardroom, as has been over the last 3 years, is simple. Trustee Randeria stands for the poor and the middle-class and wants that the benefit of this conversion must first be given to them, unlike the three other Trustees who would rather give it to their family and friends.

Those who are unable to pay lakhs of rupees in stamp duty cannot be left as Licensees, whereas those who can afford to pay, get their tenancies. This unfair disparity between rich and poor must not be allowed to be perpetuated further.

Parsi Times R. ADIL MALIA: Candidate 'No. 1'



PT asked Dr. Adil Malia (Your Candidate No.1): Being an accomplished 'People Professional', what would you suggest to our Parsi / Irani Voters to look out for whilst choosing the 'Best Candidates' in the BPP Elections?

- * Self-Control
- * Humbleness



Unfortunately, community every proverbial tinker, tailor and sailor thinks that he or she can become a trustee. Yes, every Parsi is as eligible to vote as he/she is to contest, but would he or she be capable enough?

In our opinion, not everyone can or should become a Trustee. Simply desiring to be a trustee doesn't mean the person has the capability, skills, knowledge, understanding or more importantly, the capacity to think and act independently - with wisdom and integrity. William Shakespeare once said, "Some are born great, some achieve greatness and some have greatness thrust upon them". We have seen what happens at the BPP when leadership is literally thrust upon some... Such trustees do harm to themselves, the BPP trust and to the community.



Since 2008, when Universal Adult Franchise was introduced for the first time under the High Court framed BPP Scheme of Elections, we have

stopped getting surprised seeing the kind of persons aspiring to become trustees... with some even making it to the proverbial hot-seat to wear the 'crown of thorns' before the community's (pun intended) is crucified! Likewise, we have stopped being surprised when those charged with Trusteeship can't seem to figure out what leadership constitutes responsibility.

Are We Ready For Change?

The question is, are we, as a community ready for change... and change for the better, or are we still going to vote blindly?

Are we still going to buy dreams that will turn into nightmares? Are we going to fall for sops and freebies, forgetting that in reality, there is 'no free lunch'? If you are promised something free, please don't forget that somewhere, someone else will be paying for it or impoverishing the charitable trust.

As a voter, be vigilant and well informed! Don't go by what you read in unregistered pamphlets that come free to you by e-mail, WhatsApp and during election season, even in print at your doorstep. Don't get carried away by fake news and what is circulated anonymously or under fictitious names in WhatsApp groups. Talk to the candidates directly or ask them questions at their campaign meetings.

Knowing The Leader...

How would you know that the person you are voting for is a reasonably good leader and 'trustee material'?

The first test would be to determine whether the person is chasing the High Position or a Higher Purpose? Find out whether the trustee aspirant is 'Power Driven' or 'Purpose Driven'? Afterall leadership is about caring about something beyond individual self and leading others to a better

place, even if it means the leader takes a back seat or ends up with no seat at all.

Power often comes with leadership, but it's not what drives real, purpose-driven leaders. A purpose-driven leader would have clear thinking and clear vision. However, vision again is not to be confused with dream merchandise that politicians usually market with attractive packaging before elections.

Sop With Mop ...

A true leader will seldom promise to give you anything. He or she will tell you and show you how collective good of the community can be achieved with cooperation. A good leader would aim for sustainability for all stakeholders and not simply offer sop with one hand and a mop with the other to sweep it

Please keep an eve on those who care more about making promises than keeping them. Always remember that leadership isn't about pomposity and grandiloquence it's about actions. Judge the sitting trustees aspiring for a fresh term by their actions and performance and not their empty words and promises. Judge all other aspirants by their track record of service to the community.

Leadership may begin with vision for a better future, but it's delivering the vision that ultimately determines success or worth of leader.

Passion And Integrity...

Only leaders who demonstrate integrity can garner trust among their fellow colleagues. These are men and women who are not afraid of the truth and are capable of standing up for what they believe in. Leaders with integrity also often have an enduring passion for what they do. They don't do what they do for name, fame or personal gain but simply because they love what they do or want to change for the good of all. In fact, it is this very passion that becomes the basis for their success, popularity and happiness.



Turn Out To Vote...

Remember that exercising vour franchise is a duty and responsibility. We know it's summer and very hot outside. We know it's the summer holidays. We know it is a Sunday. We also know that a degree of 'voter fatigue' may have set in. Also, 'nothing will change' is a common refrain that we may hear. But, by not voting, things could change by default for the

Also, if you think that just your one vote in a pool of a few thousand cannot make much of a difference, consider some of the closest elections in the recent history of the BPP where good candidates have lost by just a few votes.

Participating in RPP elections is one of the key freedoms and rights of a Parsi Zoroastrian. No matter what your personal ideology may be or who you may wish to support, it is important for you to exercise your right to vote!





ખરી બાબત એ છે કે આપણે

કુદરતમાં જે કાંઇ સાચુ હોય તેવુ યોજના પૂર્વક કોઈક ભલી નેમથી આ ન મેળવવં તે કાંઇ ગનાહ નથી. ભલા દેશમાં આવ્યા છીએ.

> બધી બાબતોનો અભ્યાસ કરતા એક સવાલ ઉભો થાય છે કે બુરા જમાનામાંબી બાતેનમાં આવા મોટા સાહેબો હોવા છતાં એમ કાંય નિર્માણ હતું કે ઈરાનમાં જાહેર દીન ટકી શકે નહીં, જ્યારે હિંદુસ્તાન ભૂમિ ઉપર એ શક્ય કાંય બન્યું?

પવિત્ર દએ મહિનો

બાર મહિનાના ઝોરાસ્ટ્રિયન કેલેન્ડરમાં દએનો મહિનો સૌથી પવિત્ર માનવામાં આવે છે કારણ કે તે સર્વોચ્ચ અમેશા સ્પેન્ટા (બાઉન્ટિયસ ઈમોરટલ), દાદાર હોરમઝદ (દએ દાદાર) - સર્જકને સમર્પિત છે. ઘરમાં, ઓફિસમાં કે આતશ બહેરામ કે અગિયારીમાં જશન સમારોહના પ્રદર્શન સાથે સર્જકને ઘન્યવાદ આપવાનો મહિનો પણ છે.

ચાર વધારાના-વિશેષ દિવસોઃ મહિનાના પ્રથમ દિવસે (એટલે કે હોરમઝદ), આઠ દિવસ (એટલે કે, દએ આદર), પંદરમો દિવસ (એટલે



કે, દએ મહેર) અને ત્રીસમો દિવસ (એટલે કે, દએ દીન) અને સર્જકનું પાસું ઘરાવતા યઝાતા – અગ્નિની અધ્યક્ષતા (દએપ આદર), પ્રકાશ અને ન્યાયની અધ્યક્ષતા (દએપ મહેર) અને સારા ધર્મની અધ્યક્ષતા (દએપ મહેર) (દએપ દીન) મહિનાના આ ચારેય દિવસો સર્વોચ્ચ સર્જકને સમર્પિત છે. આ ચાર દિવસમાંથી દરેકને દાદગાહ (સર્જક)ના જશન તરીકે ઓળખવામાં આવે છે.

પ્રાચીન ઈરાનમાં દએમાહની ઉજવણીઃ

પ્રાચીન સમયમાં, જ્યારે પારસી ધર્મ ઈરાનનો રાજ્ય ધર્મ હતો, ત્યારે માહ દએ અને રોજ હોરમઝદ પર, જૂના મહાન રાજાઓ તેમના સિંહાસન પરથી નીચે ઉતરતા, સાદા સફેદ વસ્ત્રોના પોશાક પહેરતા, બધા શાહી પરિચારકોની ફરજો દિવસ માટે સ્થગિત કરતા અને રાજા સાથે વાર્તાલાપ કરવા ઇચ્છતા કોઈપણ સામાન્ય નાગરિક માટે પોતાને ઉપલબ્ધ કરતા હતા.

રાજાઓ નાના જમીનમાલિકો અને ખેડૂતો સાથે બેઠકો યોજતા – તેમની સાથે સાદું ભોજન પણ વહેંચતા. આ પરંપરા વાર્ષિક સ્મૃતિપત્ર હતી કે સર્વોચ્ચ દિવ્યતા માટે, દાદાર હોરમઝદ, રાજા અને સામાન્ય બધા એક સમાન છે. તે ભગવાન અને તેની બધી રચનાઓ સાથેની મિત્રતાની ઉજવણી કરે છે – ખાસ કરીને મનુષ્યો વચ્ચેની મિત્રતા, શ્રીમંત કે ગરીબ, શાહી અથવા સામાન્ય.

ભગવાન સાથે મિત્રતાઃ

અમુક ધાર્મિક પરંપરાઓમાં ભગવાનને ભયાનક



દેવતા તરીકે જોવામાં આવે છે (વિશેષણ -ભગવાનનો ડર અંગ્રેજી લેક્સિકોનમાં સામાન્ય છે) અથવા ભગવાન અથવા માસ્ટર તરીકે. જો કે, પારસી પરંપરામાં અહુરા મઝદાથી ન તો ડરવું જોઈએ કે ન તો ડરથી તેમની પૂજા કરવી જોઈએ. પારસી પરંપરામાં અને ખાસ કરીને ગાથામાં, સર્વોચ્ચ દિવ્યતાને ફ્રયા (સંસ્કૃત પ્રિયા) અથવા ફ્રિયાઈ તરીકે ઓળખવામાં આવે છે જેનો અર્થ મિત્ર અથવા પ્રિય છે. બીજા શબ્દોમાં કહીએ તો, ભગવાન સાથે પારસીનો સંબંધ ભય અને

ડરના આઘારે નહીં પરંતુ મિત્રતા અને પ્રેમના આઘારે બાંધવામાં આવે છે.

ભગવાનને પ્રેમ કરવો જોઈએ, તેના ક્રોઘથી ડરવું નહીં. ભગવાનને મિત્ર તરીકે માનવા જોઈએ અને માંગણી કરનાર અથવા પ્રભુત્વ ઘરાવનાર ભગવાન તરીકે નહીં કે જેઓ સતત તેની પ્રજાને પરીક્ષણ અને બલિદાનમાં મૂકે છે. પારસી પરંપરામાં ભગવાનને બલિદાન અથવા શરીરને ત્રાસ આપવાથી પ્રસન્ન થવાના નથી. વાસ્તવમાં, એક મિત્ર તરીકે અહુરા મઝદા ઈચ્છે છે કે તેના તમામ મિત્રો ઉશ્તા અથવા સુખનો આનંદ માણે.

ભગવાન સાથે મિત્રતા કેવી રીતે કરવી? દાદાર હોરમઝદ સાથે આપણે કેવી રીતે શ્રેષ્ઠ મિત્રતા કરી શકીએ?

જેઓ પરોઢિયે હોશબામ ખાતે પ્રાર્થના કરે છે તેઓ પ્રાર્થનાને યાદ કરી શકે છે: "Asha vahishta, asha sraeshta, daresāma thwā, pairi thwā jamyāma, hamem thwā hakhma.", જેનો અર્થ છે – તમારા દર્શન અને અમે તમારી નજીક આવીએ અને તમારી શાશ્વત મિત્રતાને પ્રાપ્ત કરીએ.

ઉપરોક્તમાંથી એક જોઈ શકાય છે કે આપણે ફક્ત આશા (સત્ય, શુદ્ધતા અને સદાચારી આચરણ)ના માર્ગ પર ચાલીને ભગવાનની શાશ્વત મિત્રતા મેળવી શકીએ છીએ.

દએના આ પવિત્ર મહિનામાં, આપણામાંના દરેક આશાના માર્ગ પર ચાલવાના આપણા દૈનિક પ્રયત્નો દ્વારા અહુરા મઝદાની મિત્રતા મેળવવાનો પ્રયત્ન કરીએ. ત્યાં એક જ રસ્તો છે, તે આશાનો, બીજા બધા રસ્તા ખોટા છે.


વુધ્ધ કહે : રાહ જોઉં છું કે, નદીનું પાણી વહી જાય તો નદી પાર કરી લઉં!

"Politics Must Take A Backseat And **Trusteeship Must Return To The Forefront,"** Says BPP Trustee And Candidate, Kersi Randeria

As the curtains are about to come down on my first term as a Trustee, six and a half years down the road... I've felt a sense of pride, a sense of satisfaction and a certain amount of despair. This will be my final communication with the community at the end of my first term as a trustee

Having thought long and hard about not offering my candidature for a second term, as my colleague, Noshir Dadrawalla has done, I decided to take the plunge, not out of any love for the chair, but out of the determination to complete the agenda that I was not allowed to complete, by people outside the BPP... and to finally put to rest, my obsession with housing the poor of our community.

I've emphasized all through my campaign trail over the last one month, that what the BPP needs the most today, is protection from itself - protection from forces within the BPP who are pandering to forces outside the BPP, and bringing the BPP and its good work to a halt.

With my hand on my heart I can say, that were it not for outside interference, this Board could have and should have performed miracles; it could have and should have

resolved many issues, including the issues of Cash-crunch, Housing, Welfare, etc.

It has been verry frustrating knowing that it is the 'enemy within', which has not allowed us to deliver on the promises we made to the community and to the Trust, as your elected Trustees.

This time around, I have realised that it's not enough just being a strong voice on the Board, but that its critical to be part of a like-minded team, which will perform collectively as a team, in the broader interests of the community.

Some community members may have perceived me to come across as harsh or rude. But it is my heart-felt concern for the welfare of the community - which has always been at the forefront... as a result of which I have sometimes been tough with people, who hoard two or three trust houses or who insist on being compensated lakhs of rupees for these accommodations which were given to them or their ancestors, free of cost, many years ago, and in which they have prospered.

I've generally been tough with those, who despite being extremely wealthy and/or are settled abroad, feel entitled to be compensated for charity flats.

I've done my best to help those who look for some monetary relief by relinquishing their rights of their house to pay their medical bill or to relocate, with a view to managing the rest of their lives comfortably.

I've always argued with my colleagues, that we must find a way to look after such people and provide them medical relief, etc., rather than letting them resort to becoming part of this 'sale of flats' program. This is a very delicate line that we

need to walk, where welfare and policy clash.

I feel a sense of satisfaction when I look back at my comprehensive body of work, which speaks for itself, through my six-and-a-half-year Trusteeship... much has been accomplished and many promises were delivered. And yet, there lingers an abject sense of frustration from the fact there are so many good projects that were stalled or sabotaged by the foreign hand or 'outside influence' on this Board, which needs to be brought to an end... and this can be achieved easily if there is a strong and dedicated team in place.

POLITICS MUST TAKE A BACKSEAT AND TRUSTEESHIP MUST RETURN TO THE FOREFRONT.

The community must remember that when you choose a candidate, you must see the candidate not in isolation, but also what he/she represents, in terms of policy. You also need to ascertain whether the candidate is an independent-thinking person, who will work as a trustee, or whether he/she will be dependent on external advice, throughout the trusteeship.

We must also identify trustees who seem to have lost their individuality and nod in unison and shake heads in unison, without any application of mind to the issues involved, or to the harm that their political unity does to the community. Take for instance, the way the community is currently being fooled by the unfortunate, desperate and pathetic attempts of some trustees who are misrepresenting the issue of conversion of charity flats from Leave & License to Tenancy. The community today is at the proverbial crossroads - something that one speaks about at all elections. However this time around, I say this with the utmost honesty, if we do not give the Trust a chance to become independent, to have likeminded, community welfare oriented, professional individuals who will deliver the goods that the community so badly needs, then the opportunity for the Trust to recover its credibility will forever be lost.

We need good people in the Chair, we need honest work being done, where welfare of the community is a priority. Only then, will the 'Trust' in trusteeship return and the world will be a better place for our small community

I have a hope in my heart, a prayer on my lips and determination in my mind to do what I set out to do, and to complete what I set out to complete, in 2015. And for this, I seek your blessing.

I seek more than your votes - I seek your support, your involvement. I want you to play a more active role, and work shoulder to shoulder with the trustees, and together we will rebuild the Trust, rebuild the BPP, rebuild the trust in BPP, and rebuild the credibility that has been lost for the last two and a half decades.
